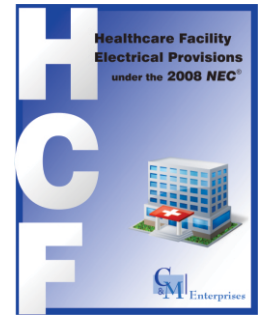

## Articles 700, 701, 702 **Bring Your Codebook!**

This training provides an introduction & overview of the 2017 NEC<sup>®</sup> requirements of Articles 700, 701, 702, related NEC<sup>®</sup> Articles, and NFPA<sup>®</sup> document 110 (Standard for Emergency and Standby Power Systems, 2016 edition) as they pertain to the electrical requirements for Emergency Systems (Article 700), Legally Required Standby Systems (Article 701), and Optional Standby Systems (Article 702). Utilizing PowerPoint<sup>®</sup> instruction, and your codebook as attendee handout material, this training provides both insight & clarity into the NEC<sup>®</sup> and NFPA-110<sup>®</sup> compliance requirements for occupancies where such systems and equipment associated with these types of installations is mandated by electrical, building, and life-safety codes. This course is well suited for designers, installers, contractors, electrical craftsmen, & enforcement who may be involved in the design, implementation, approval or construction of such systems and equipment, even if such installations are based upon earlier NEC<sup>®</sup> versions. Attendees benefit by bringing their personal NEC<sup>®</sup> codebook.

## Health Care Facilities **Bring Your Codebook!**

This course provides overview & instruction into the 2017 NEC requirements of Article 517, and related NEC<sup>®</sup> Articles as they pertain to the electrical provisions for health care facilities (HCFs). Attendees will gain exposure, valuable insight & become familiar with the NEC's<sup>®</sup> seven parts of Article 517 which include provisions for HCF electrical general requirements, definitions, wiring & protection, essential electrical systems, inhalation anesthetizing locations (basic overview), X-Ray installations, communications, signaling & fire alarm systems, and isolated power systems. While utilizing multi-sourced PowerPoint presentation instruction material, and your codebook as attendee handout material, attendees will have exposure to authoritative information on health care facility electrical installations and requirements. Health care facility electrical installations will generally require compliance with electrical provisions contained within NFPA's<sup>®</sup> document 99-2015, the 'Health Care Facilities Code' recognized as establishing criteria (among others) to minimize hazards associated with electricity within health care facilities. While NFPA<sup>®</sup> 99-2015 introduction and compliance will be addressed as appropriate during the day's training, instruction is centered on the in-depth overview of the NEC's<sup>®</sup> Article 517 and other applicable NEC<sup>®</sup> requirements. This training is well suited for electrical contractors, craftsmen, design professionals, enforcement, plan reviewers, and anyone in need of expanding their understanding and comprehension of HCF electrical requirements. Attendees will benefit by bringing their personal NEC<sup>®</sup> codebook.

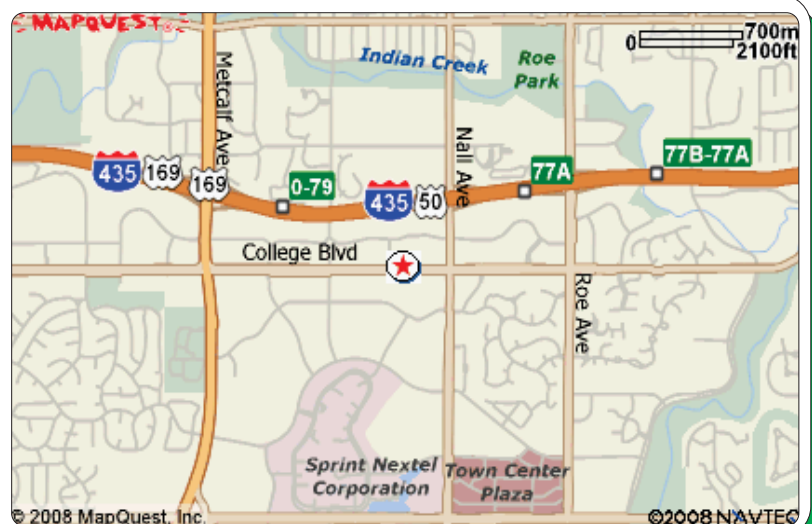
